She relayed that the septic system was working fine prior to the construction of the Runnalls Drain. The excess soil that was supposed to be hauled away was spread over her septic tile bed. The Council informed Mrs Baker that they will discuss this further at the end of the Council meeting and will make a decision.

b- Runnalls Drainage Update

WHEREAS in the fall of 2015, the Contractor started to construct the Runnalls Drain;

AND WHEREAS in 2016 more work was performed on the Runnalls Drain, such as fine grading on the north side of the newly constructed ditch, and to push excess soil from the Baker's property to the West of the Drain;

AND WHEREAS in early May 2017, the Health Unit received a Sewage Smell Complaint from the Owner of Roll #5424 000001 08805;

AND WHEREAS on May 3<sup>rd</sup>, 2017 an inspection was conducted by the Health Unit, and the Inspector advised the Owner that the previous owner had installed a new tank in 2005 but they have no records of any septic tile bed on their property;

AND WHEREAS the Health Unit Inspector did smell sewage, and noticed a large amount of water lying on their property, he performed a dye test and informed the Owner that he will be back the next day to inspect again;

AND WHEREAS on May 4<sup>th</sup>, 2017 at 7:00 pm the Inspector noted that the water had receded on the property and he could see trenches on their property going West, and he noticed that fill was placed over the Westerly portion of the trenches;

AND WHEREAS the Health Unit Inspector advised the Owner of the property that they need a new Class 4 sewage system to solve their problem;

AND WHEREAS the Township of Kerns with the authorization of the Owner dug two test holes to locate the septic tile bed and to see the condition of the tiles they are in;

AND WHEREAS the Township of Kerns did find two trenches and the tiles were filled with water;

AND WHEREAS the Owner of the property is requesting the Township to pay for the new septic tile bed, because the excess fill was layed on the westerly portion of the septic tile bed and by doing so the tiles were crushed;

NOW THEREFORE be it resolved that the Council of the Township of Kerns do hereby agree to contribute 50% towards the cost of installing a new septic tile bed, as recommended by our engineer, conditional to the owner signing a Final Release.

Councillor Aitchison requested a recorded vote.
