Tri-Town Sno Travellers

The 'A' trail had to be moved this year as a land owner did not give permission for the trail to cross his property. The Tri-Town Sno Travellers & Club Echo (TTST) looked into other possible routes, but the only quick fix is to come out at Kerns' Cemetery and cross the bridge on Fairview. They would like to try it for this winter season and will check the bridge weekly for damages. The TTST is willing to come up with an agreement to provide funds for damages on a yearly basis. Several experts have been consulted regarding the possible damage outcomes by the TTST and there are mixed opinions. The TTST believes the 'A' trail may only be in this location for a year, so an official agreement for damage compensation may be unnecessary. Should substantial damage to the bridge deck occur, the TTST will not continue to cross the bridge, and will instead build a snow bridge or close the trail to avoid further damage. The TTST will put up a snowmobile crossing sign at the bridge. The Roads Superintendent requested they approach the bridge differently to avoid the blind spot.
